G2Media Hire Terms and Conditions

In addition to the G2Media General Terms and Conditions located at www.g2media.com.au

the following Terms and Conditions will also apply for any Hire related services:

HIRE CONTRACT CONDITIONS

These Hire Contract Conditions apply to the exclusion of any other conditions proposed by the Customer, unless otherwise agreed by G2Media and the Customer in writing. G2Media agrees to hire Equipment to the Customer on terms set out in this document. If the Customer wishes to hire Equipment the Customer must complete and sign (or otherwise accept in the manner required by G2Media) a Hire Schedule and such other documents as G2Media may require. Each Hire Agreement is not a separate contract but forms a part of this hire agreement between G2Media and the Customer, together with any credit application, guarantee and indemnity or other contractual documents. G2Media may in its absolute discretion decline to hire Equipment to the Customer at any time if it has reasonable cause to do so. Amendment: These Hire Contract Conditions may be changed by G2Media from time to time by G2Media giving notice of the amendment to the Customer. Notice is deemed given (whether or not actually received) when G2Media does any of the following: (a) sends notice of the amendment to the Customer at any address (including an email address) supplied by the Customer; (b) publishes the amended terms on its website www. G2Media.com.au; or (c) displays the amended terms at premises from which G2Media conducts hire operations. Changes to these hire Contract Conditions will only apply to Hire Agreements entered into after the change occurs.

1.1 DEFINITIONS

Interpretation of Words in Hire Contract;

Commencement means the date when the customer takes possession of the quipment. Equipment means any kind of equipment, Solar Cams, LED Screens, LED Trailers, Media Players, Stands, Cables etc.

Hire Charge means the amounts shown on the Hire Charge Agreement and Hire Invoice payable by the customer to hire the equipment.

Hire Period means from Commencement until the end of the period shown on the Hire Agreement. The Hire Period may be extended for additional periods if agreed to by G2Media and the customer. G2Media may issue and require the Customer to sign an amended Hire Agreement for any extension of the Hire Period. Hire Agreement means a document which G2Media may require the Customer to sign (or accept in a way G2Media requires) including particulars of the Equipment and the Hire Period and such other information as G2Media may decide to require. G2Media – The company or companies listed on the Hire Agreement Remote Area means any location which is more than 50km from a G2Media branch from where the equipment is hired.

1.2 G2Media OBLIGATIONS

G2Media will:

- **1.3** Allow the Customer to take and use the Equipment for the Hire Period:
- **1.4** Provide the Equipment to the Customer clean and in good working order;
- **1.5** Collect the Equipment within 5 days of being requested to do so by the customer.

2.0 OBLIGATIONS OF THE CUSTOMER

The Customer must:

- **2.1** Allow G2Media to pick up the equipment when it is due back:
- **2.2** Return the Equipment to G2Media clean and in good condition;
- **2.3** Satisfy itself at Commencement that the Equipment is suitable for its purposes;
- **2.4** Operate the Equipment safely, strictly in accordance with the law, only for its intended use, and in accordance with any manufacturer's instructions whether supplied by G2Media or posted on the Equipment; In the event that You instruct Us to place the Electronic Traffic Control Equipment, you warrant

that you will provide Us with all information relevant and available for the safe placement of the Electronic Traffic Control Equipment. You are liable for and indemnify G2Media against all liability, claims, damage, costs and expenses arising from the placement and operation of Solar Cams, LED Trailers and LED Screens. You agree that you will not use LED Trailers or LED Screens for advertising or marketing purposes where such use contravenes any laws, government or local council regulations. You are liable for any fines that may be issued from any incorrect use or placement of the equipment.

- 2.5 Indemnify G2Media for all injury and/or damage caused or contributed to by the Customer to persons and property in relation to the Equipment and its operation and have adequate insurance to cover all liabilities incurred as a result of the use of the Equipment:
- **2.6** Ensure that any person collecting or taking delivery of Equipment on behalf of the Customer is authorised by the Customer to do so and the Customer will not allege that any such person is not so authorized;
- 2.7 Ensure that all persons operating or erecting the Equipment are suitably instructed in its safe and proper use and where necessary hold a current Certificate of Competency and/or are fully licensed;
- **2.8** Conduct a thorough hazard and risk assessment before using the Equipment and comply with all Occupational Health and Safety laws relating to the Equipment and its operation;
- **2.9** Indemnify G2Media in respect of any injury and/or damage caused by items falling from any Solar Cams, LED Trailer or LED Hire Screen and Mobile Stand operated by or on behalf of the Customer;
- **2.10** Operate the Equipment with an adequate power source;
- **2.11** Report and provide full details to G2Media of any accident or damage to the Equipment within 2 business days of the accident or damage occurring.

The Customer must NOT;

- 2.12 Tamper with, damage or repair the Equipment;
- 2.13 Lose or part with possession of the Equipment;
- **2.14** Rely upon any representation relating to the Equipment or its operation other than those contained in this Contract:
- **2.15** Allow any person to relocate Solar Cams, LED Trailers or LED Hire Screens. The customer must contact G2Media if relocation of equipment is required

2.16 Payments by the Customer to G2Media

- **2.17** On or before Commencement (or as otherwise specifically agreed with G2Media), the Customer will pay the Hire Charge.
- 2.18 Immediately on request by G2Media, the Customer will
- (a) the new list price of any Equipment which is for whatever reason not returned to G2Media. (NOTE TO CUSTOMER: Subject only to any express provision of this Contract to the contrary, the Customer is responsible for loss or theft of the Equipment),
- (b) all costs incurred in cleaning the Equipment;
- (c) the full cost of repairing any damage to the Equipment caused or contributed to by the Customer, unless expressly agreed otherwise in this Contract;
- (d) stamp duties, GST, any other taxes or duties, and all tolls, fines, penalties, levies or charges payable in respect of this Contract or arising from the Customer's use of the Equipment:
- **(e)** Upon Damage or Theft to equipment the customer is obligated to pay a \$500 excess towards recovery costs.
- (f) a late payment fee calculated daily at 2% per month on all amounts owing by the Customer not paid on time.

2.19 Hire Extension Confirmation & Payment

The Customer has an obligation to advise G2Media 7 days prior to end of the Hire Agreement Date of their intentions to cease hire of equipment in writing via email.

2.20 G2Media has been Authorized to process a payment from nominated credit card for additional minimum 4 weeks hire upon initial hire expiry.

2.21 Security Information

G2Media is authorized to collect credit card details from the customer as a bond requirement.
